

PARTNERSHIP AGREEMENT

between Dniprovsky State Technical University (DSTU), Kamianske, Ukraine, represented by Rector, Professor, Doctor of technical sciences Vitalii Guliaiev and University of Rijeka, Opatija, Croatia, Faculty of Tourism and Hospitality Management, represented by Dean, Marko Perić, PhD, Full Professor, acting on the basis of the Charters and hereinafter referred to as the Parties.

Section 1

SCOPE OF THE CONTRACT

The main purpose of the contract is long-term cooperation on improving the modern education system in Dniprovsky State Technical University (DSTU) Kamianske and Faculty of Tourism and Hospitality Management, exchange of work experience, development of scientific, educational, cultural and international relations. The Contracting Parties will by all means facilitate the implementation of all provisions of this agreement.

Section 2

MAIN DIRECTIONS OF COOPERATION

The parties agreed on the main areas of cooperation in the areas:

2.1 Educational work

2.1.1 Exchange of scientific and pedagogical workers to deliver lectures determined by the profile of partner educational institutions.

2.1.2 Exchange of experience and results in educational and methodological as well as upbringing work.

2.1.3 Development of joint educational programs for obtaining double diplomas.

2.1.4 Internship of scientific and pedagogical workers, students of higher education in partner educational institutions.

2.1.5 Increasing the effectiveness of the educational process on the basis of modern methods and means of education.

2.1.6 Exchange of educational and educational-methodical literature, curricula and programs on a mutual basis.

2.1.7 Fostering contacts between scientific and pedagogical workers and students of higher education.

2.1.8 Organization of training and educational practice of students of higher education in partner educational institutions.

2.2 Scientific work

2.2.1 Conducting joint scientific research within the framework of international projects, programs and grants.

2.2.2 Exchange of modern scientific information, publication of scientific articles and results of scientific research in scientific editions of the Parties, following all the prescribed procedures.

2.2.3 Exchange of experience in scientific work, professional development and internship of scientific staff in partner educational institutions.

2.2.4 Organization of joint seminars, conferences and invitation of partners to upcoming conferences.

2.2.5 Implementation of scientific developments in the partner country.

2.2.6 Mutual scientific guidance for the preparation of theses.

2.3 Cultural and international relations

2.3.1 Familiarizing students of the above-mentioned educational institutions with the history and culture of both countries.

2.3.2 Exchange of experience in the field of international cooperation.

2.3.3 Managing tourist group exchange.

Section 3

TERMS OF COOPERATION

3.1 The parties ensure non-disclosure of confidential information obtained during joint work. The transfer of information received by one of the Parties to a third party is carried out with the mutual consent of the Parties.

3.2 Direct cooperation is carried out in accordance with work programs.

3.3 Work programs provide for specific topics of joint activities and are developed based on the proposals of the two Parties.

3.4 The topics and duration of work programs are agreed upon by both Contracting Parties.

3.5 The financial conditions of cooperation are determined by the Parties for each specific event by concluding additional contracts and in accordance with the financial capabilities of the partners. It is also possible to involve other organizations and funds in funding this cooperation.

This agreement does not exclude other forms of cooperation that may be proposed for discussion at the initiative of each of the Parties.

Section 4

TERMS OF THE CONTRACT

This agreement shall remain in effect for a period of three (3) years from its effective date. It may be renewed or amended at any time before the actual expiration date by a written agreement signed by authorized representatives of both parties. This agreement may be terminated by either party upon one (1) month prior written notice to the other party. The contract can be terminated at the will of one of the Parties, which must be notified to the other Party no later than one month before the moment of its termination. The Agreement may be supplemented, changed or extended by mutual consent of the Parties. Continuations, additions and changes to the contract are drawn up in separate agreements. The contract is signed in 2 copies in English language.
